# POLICE CARE UK

This was formerly known as the Police Dependents Trust and as the branch welfare officer I have had recent contact from David Blundell who is the Engagement Officer for the above charity. He has contacted all NARPO branches to raise awareness of what the charity can offer to serving and former officers/staff who have suffered harm, physical or psychological, as a result of the tasks that had to be carried out in their police duties.

The charity offers the following:

- 1. Funding for house adaption/mobility equipment
- 2. Support for early leavers.

3. Respite for families.

- 4. Assistance grants (but not to clear loans/debt/mortgage payments)
- 5. Confidential care line for counselling/psychotherapy.

I am sure we can all recall incidents that have affected us or you may know colleagues/friends that are struggling. Some people are able to cope but others may still be struggling. This confidential charity may be the lifeline to help people, it's not a weakness to say you need help, in fact I would go so far as to say it's a strength to say "I need help, be it mentally or financially.
