Email addresses


We have 205 members who **HAVE** an email address but have not registered to receive their Cumbrian newsletter by email which means we have to pay for printing and postage.

It was felt that much of the document did not apply to Cumbria and therefore your committee decided to produce a more Cumbrianised version. Subscriptions for 2025

The subscriptions for 2025 will be £26.76, as you will be aware this is taken monthly from your pension at £2.23 per month. If you do not pay through your pension, we send letters to everyone asking for payment by 1 January – if you forget you will receive a reminder in February.

Raffle

At the AGM this year it was agreed that we should hold a raffle, one at Christmas and one in the summer. Don't panic it cost you nothing. We will enter all FULL MEMBERS into a draw and by the miracle of a computer a membership number will be drawn this will give the member selected £100 cash prize. We will also have a draw for additional members (such as our widows) who do not pay a yearly subscription to Narpo, the lucky number will receive a prize of £50. 2025 Conference

This will be held in Blackpool and members of your committee will be in attendance.

Incorporated company – Narpo are now an incorporated company governed by Company Law. Those members of the National Executive Committee are now Directors of the company. One of the Directors is our Secretary and No 1 Regional Representative Kate Rowley QPM.

The CEO updated the Directors on the following:

- Widows/Widowers Pension for Life –. NARPO will continue its campaign with Connect and look to arrange a Parliamentary Drop In on 15th January 2025.
- Pensions remedy- there are ongoing discussions on McCloud and Remedy, particularly on RSS There are regular updates on these issue on the national website <https://narpo.org/pensions-challenge-update/>
- NARPO Pensions Board-. The next meeting will be 10th December. Ongoing issues regarding McCloud and Remedy, Representatives from Head of Police Pensions at NPCC and XPS will be attending the meeting.
- Budget- there could be an impact of the changes to Inheritance Tax for their families which receive a death in service gratuity. This is being progressed by the Police Federation
- CEO is part of the NPCC Pension Chat
- Pensions Board- MJ presented his paper on the NPCC proposal for a National Pensions Board . There were concerns that local Pension Boards, on which

NARPO may be represented, would lose their influence on local issues. The CEO had contacted and spoken with the NPCC lead on Pensions. At the moment, it is a proposal to be discussed by NPCC Chief Constables Council. If it were agreed, there would be a national Board, on which ,NARPO would have representation. This would strengthen NARPO's position nationally. In addition, the intention would be to have some local structures to deal with local issues. It was agreed that local NARPO representatives on local Pension Boards would ask about this proposal, as this may not be widely known. There will be the opportunity to ask the NPCC national lead when they attend the next meeting of the NARPO Pension Board on 10th December.

All items discussed at the meetings of the Directors are contained in the minutes of those meetings and are available on the Narpo website when agreed at the next meeting of the board. The next meeting will be held in Humberside on the 5th February 2025 and issues relevant to our membership will be reported on after that date.
