## President's Review

September and October have been particularly busy for us. September began with our annual Conference which this year was held in Torquay. It was not sunny but very, very wet. However, within the conference hall itself, all went well.

This year was the first year that delegates who could not attend in person could, instead, appoint proxies to vote on their behalf and we achieved reasonable numbers who took advantage of the opportunity.

We used an external company that made all the preparations and pre-loaded the proxy votes onto electronic voting machines. In the event, delegates experienced no difficulties using them which quickly and efficiently and produced the results of the votes cast.

We hosted a meeting between ourselves and representatives of the Scottish Retired Police Officers Association, the Northern Ireland Retired Police Officers Association and the Garda Siochana where we were able to agree on issues which affected all of us and on which we can cooperate with our mutual benefit.

We also held a meeting with the Police Federation and attended the Superintendents Association Conference where we were able to explain the benefits of NARPO membership to

At our regular meeting with the joint members of Later Life Ambitions and Connect (our Parliamentary advisors), we made firm proposals to progress meetings with senior and influential members of Parliament. Later we attended as guests at LLA member, the Civil Service Pensioners Alliance Conference.

Looking at our progress, we have already had several meetings with Dame Diana Johnson, the new Police Minister, and have diary meetings with several other Members of Parliament to progress our claims, especially the implementation of the Police Covenant and the

> Widows Pension for Life Campaign and have already arranged a drop-in at Parliament for MPs of all parties on 20th November to meet with several widows who have been adversely affected by the current pension rules.

By the time you will have received this copy of NARPO News the Autumn Statement (budget) will have been presented and we will all know what is in store for each of us. We have arranged a meeting to follow with our LLA members to consider how we should react to it.

Two other events which I was privileged to attend were the Memorial Dedication to Sergeant Matt Ratana who was shot and killed in the Custody Suite in Croydon, South London, four years ago and, later that week to the National Police Memorial Day in Glasgow. Both events were very well attended and moving ceremonies. We hope to include further details of both in the next issue of this magazine.

So, may I now sign off by taking this very early opportunity to wish you and your families and very Happy Christmas and a peaceful, prosperous 2025.

#### Nostalgia Behind the Wheel

A former detective from Lancashire has taken a trip back in time behind the wheel of a rare police sports car – the type he first drove way back in the 1960's! John Clark was reunited with the MGA Roadster at the Lakeland Motor Museum in Cumbria. The Museum exhibit was one of a small number of MG's supplied to the Lancashire Constabulary for traffic patrol and training duties over 60 years ago. John drove one of the fleet during his Advance Driver Training in 1962.

"They were happy days!" says John who joined the police in 1956, "It was a beautiful car back then and it's still a beautiful car now!

"They had only just come out when I first got behind the wheel of one of them so they were brand new. It's hard to believe they are now a museum piece – time flies!"

John, originally from Lossiemouth in Scotland, only joined the police following a dare with a mate when they saw a Lancashire Constabulary recruiting bus while visiting a football

match in nearby Elgin. "We both decided to do the entrance exam there and then and passed" he says. "I never saw the football match!"

He went on to become a senior detective, served with the Regional Crime Squad and was awarded the Lancashire Constabulary's William Garnett Cup for Bravery – after capturina an armed criminal following a roof top chase. He ended his career as a Chief Superintendent in Lancaster. He retired in 1986 and still lives in Darwen near Blackburn. He remembers the MGA Roadsters fondly. "When we first arrived at the police driving school, we saw all these officers sitting in them with their sunglasses on smiling!" says John. "I was well over 6 feet tall, so it was something of a squeeze to get in. But they were lovely cars to drive. It was a bit

easier to get behind the wheel back then than it is now I'm in my 90's!"

The engine was known to be temperamental, but the cars could ao from 0-60mph in 12.2 seconds reasonably quick for that era and good enough to keep in touch with many lawbreaking motorists. The top speed was 110 mph and they did 27 miles per gallon. In Lancashire, the MGA Roadster police cars were divided into white (A Class) and black (B Class) contingents. They had uprated running gear that was similar to the 1600 Deluxe model but with drum rear brakes instead of discs and bolt on steel wheels. After his retirement from the police, John went on to become Superintendant of Darwen Market for many years. Serving in the police is a family tradition. He met his wife, Megan, at the police regional training centre in Warrington. They had two sons and a daughter - all of whom went on to serve in the police force! He's also a grandad and a great grandad.

#### **Survey Participation Invitation**

Having retired from policing in 2023, I am currently conducting doctoral research in collaboration with the National Police Chiefs' Council and Northumbria University.

My study focuses on stressors potentially affecting well-being outcomes in Senior Investigating Officers (SIO's) within the workplace. This includes impact factors such as the unpredictability of work demands, prolonged tours of duty, passion for the job, the ability to detach and recover outside of work, and peer support. Despite growing attention on police officer well-being, this area remains critically under-researched. Please visit my engagement website www.markdimelow.com for fuller information around the project research aims and objectives.

In the earlier phases of this research, I engaged with academics and strategic leaders within policing, to compare existing theories with the realities faced by contemporary investigators.

I am inviting current and retired SIO's to participate in two short, anonymised online surveys, spaced two weeks apart. This work is part of a broader study aimed at developing evidence-based understanding to provide feedback to the NPCC, with the goal of informing the debate and improving working conditions for currently serving SIOs.

"The SIO role is extremely challenging and demanding, with extraordinarily high levels of risk and accountability. There is a lot of expectation and pressure to cope with the various demands and deliver a successful outcome." Cook and Tattersall (2010, p.31) noted.

#### **Remembering Airmen of WWII**

My contribution is with regard to the article relating to the 'Cannock Chase German Military Cemetery', submitted by Mark Judson.

As the aircraft crashed down, after anti-aircraft fire, onto an important railway line there was little time to conduct a full examination of the crash site.

The urgent repair of the railway damage was imperative and was carried out. The bodies of three air crew who were killed in the crash were removed from the wreckage and the crater was filled in and the rail track rapidly re-laid.

The bodies of these airmen were subsequently buried in the Commonwealth Graves site at Thornaby cemetery, North Yorkshire, and items recovered from the debris offered identification of:- Pilot - FW Joachim Lehnis of Denzig, born 18.8.1918, Observer:- LT. Rudolf Maternof Paderborn, born 20.8.1917 and Gunner/Mechanic:- OBFW

Heinrich Richter of Hirschberg, born 16.7.1911.

On 26th November 1997, sewerage works were being carried out near the site which resulted in the Dornier aircraft being unearthed, once again. A full examination of the site was carried out and the remains of a fourth airman and additional items were found in the wreckage.

Following forensic tests these remains were found to be those of Heinrich Richter, whose name was ironically carved onto a headstone of one of the graves in Thornaby cemetery of one of the originally found airmen, in the belief that Heirich Richter was one of the three airmen recovered from the wreckage in 1942.

Further enquiries revealed that the Dornier crew consisted of the Pilot:- FW Joachim Lehnis of Denzig, born 18.8.1918, Wireless Operator:-UFFZ Hans Manake of Berlin, born 26.4.1918, Observer:- LT. Rudolf Matern of Paderborn, born 20.8.1917 and Gunner/Mechanic:- OBFW Heinrich Richter of Hirschberg, born 16.7.1911.

The headstone, bearing Heinrich Richter's details, was removed and replaced with a new headstone, having been commissioned, bearing the details of Hans Manake, and placed upon the grave. The burial of the remains of Heinrich Richter took place on 14th October, 1998 with the initial headstone being positioned accordingly.

A contingent of members of Richter's family and representatives of the Luftwaffe attended, together with 46 UK. Military Association Standards being paraded and a Bugler sounding the Last Post and Revielle as a salute in respect of a Military Serviceman.

Richter had two brothers who also lost their lives in WWII.

The NARPO 2024 Annual Conference took place on Friday, September 6th, 2024, featuring a day packed with discussions, updates, and decisions relevant to the association and its members.

At the start of the conference, President Richard Critchley opened the proceedings by welcoming the delegates and noting important housekeeping matters, such as the election of scrutineers.

#### **Presidents Address**

The President delivered a formal address, reaffirming NARPO's core mission, which is to safeguard the rights and welfare of retired police officers, particularly in relation to police pensions. He highlighted NARPO's purpose of ensuring that whenever members are in need, the organisation is ready to offer support.

The President reflected on the past year, describing it as the busiest and most significant year in NARPO's 105-year history. He detailed the transition to incorporation as a limited company, a decision made at the 2023 conference with an overwhelming 76% vote in favour. This legal shift, finalised on 1st July 2024, provided additional financial protections for members while maintaining NARPO's core structure. He thanked the NEC, advisors, and staff for their unwavering support in ensuring the smooth transition.

The President also touched on broader political changes, emphasising NARPO's proactive political engagement, including meetings with key politicians across party lines and the ongoing partnership with the Later Life Ambitions group to address issues such as pensions, social care, and digital exclusion.

Additionally mentioned was the ongoing progress of the Police Covenant, which aims to ensure comprehensive welfare for retired officers. He noted the involvement of CEO Alan Lees in representing NARPO at the Police Covenant Oversight Board, sharing the key findings from the "Transitioning into Retirement" survey launched by NARPO in February 2024. This survey, initiated to gain a deeper understanding of the retirement experience of the NARPO membership, garnered a massive response from over 3,000 members, offering invaluable insights into the challenges and opportunities faced. The President highlighted that the survey was part of NARPO's commitment to offering better support to members as they navigate the transitional period of retirement.

Additionally, the President recognised the loss of Brian Burdus, a former NARPO President and NEC member, and welcomed Chris Morgan as his replacement. He also introduced Steve Wilcock, the newly appointed Deputy CEO, and Melissa Colbeck, the new Business Support Officer, acknowledging their contributions to the association.

He noted the involvement of CEO Alan Lees in representing NARPO at the Police Covenant Oversight Board, sharing the key findings from the "Transitioning into Retirement" survey launched by NARPO in February 2024.

### **Annual Report** and Finances

Alan Lees, the CEO of NARPO, presented the Annual Report for 2023, providing an overview of the organisation's activities, achievements, and challenges over the past year. This was then followed by Treasurer Richard Atkinson, who presented the Accounts for 2023, offering insights into NARPO's financial health, expenses, and revenues, ensuring transparency and accountability.

#### **Rule Changes**

Delegates reviewed two important resolutions regarding changes to the Rules and Articles that were agreed upon at the 2023 conference. These changes aimed at improving the governance structure of NARPO. Both Rule changes were passed.

#### Resolution on Minimum Subscriptions

A resolution, proposed by the London Branch, addressed the minimum subscription fees for membership. This was discussed extensively by delegates. The resolution lost.

#### Membership Suffrage Resolution

Another special resolution from the London Branch focused on membership suffrage, proposing changes to voting rights within the organisation. This resolution lost.





### Police Covenant and Welfare

The afternoon session began with a video presentation from the National Police Wellbeing Service Director, Andy Rhodes, discussing the role and future of the Policing Covenant.

The next segment featured a presentation on the Befriending initiative undertaken by the London Branch, led by Tim Mann. This scheme is designed to address the issue of loneliness among NARPO members, particularly those who may feel disconnected in retirement. The aim of the initiative is to foster meaningful connections by pairing members in need of companionship with fellow NARPO members who volunteer their time to offer friendship and support. Through regular phone calls and visits, the Befriending initiative helps

to reduce isolation and improve the overall well-being of participating members.

CEO Alan Lees presented the findings from NARPO's "Transitioning into Retirement" survey, which gathered responses from over 3,200 retired officers. The survey highlighted significant gaps in support for retiring police officers, with 71% reporting they received little to no help in preparing for retirement and 95% receiving no further support from their

forces post-retirement. Key concerns included mental health issues, feelings of abandonment, and a lack of financial guidance. Many respondents praised NARPO for providing crucial post-retirement support, particularly through social connections and welfare services. The findings will shape NARPO's future welfare strategy, enhancing collaboration with police forces and advocating for better transition processes under the Police Covenant.

The elected reserves for the NEC were officially noted as per the Annual Report, with conference bidding farewell to outgoing NEC members and welcoming the new NEC members who will serve in the coming term

President Richard Critchley officially closed the conference, thanking all attendees and participants. He also announced that the 2025 NARPO Conference would be held at the Winter Gardens in Blackpool on Friday, September 5th, 2025.

## **Benefits Update**

#### **Pensions, Tax and Benefits**

- On 30 October, Chancellor of the Exchequer Rachel Reeves will deliver the autumn budget, accompanied by a full fiscal statement from the Office of Budget Responsibility. The budget will set out the government's planned spending and revenue gathering going forward.
- The full new State pension is likely to increase by almost £9 to £230 a week from next April equating to £11,962 a year as a result of the 'triple lock', latest wage growth figures have suggested.
- Five 'legacy' benefits are being retired with Universal Credit taking their place as the DWP attempts to simplify the benefits system. Income Support, Income-based Jobseeker's Allowance, Housing Benefit, Working Tax Credit and Child Tax Credit will eventually be replaced by Universal Credit.
- Vulnerable households will receive support for the cost of essentials this winter, as the DWP has announced an extension to the Household Support Fund for the next six months.
- The Scottish government has expanded their pilot to seven new local authority areas for new claims to Carer Support Payment, their replacement for the DWP's Carer's Allowance for eligible citizens living in Scotland. Further information, including the pilot areas and how to claim, can be found on mygov.scot
- Thousands of people missing Home Responsibilities Protection on their National Insurance record could boost their State pension for free. Some parents who claimed child benefit before 2000 are missing out on State pension payments they are entitled to because of gaps in their National Insurance records but may be able to top up their State pension. You can check if you're eligible online: www.gov.uk/homeresponsibilities-protection-hrp/eligibility
- The Pensions Dashboards Programme (PDP) has confirmed that gov.uk's 'One Login' will be the identity service provider for anyone using the dashboards service. One Login ensures users only have to prove their identity once and can use this proof to access other services they use. This means users who have already registered to use government services through One Login will not have to prove their identity again when registering to use the dashboards service.

#### **General**

- $\bullet$  The cost of a first-class stamp is to rise by 30p in October the fifth increase in less than three years. The price goes up to £1.65 as of 7 October, while second-class stamps will remain at 85p.
- The government has unveiled plans for a new Renters' Rights Bill. The bill will introduce enhanced tenant rights and protections, including the power to challenge unreasonable rent increases, and will see the practice of rental bidding wars come to an end. The bill will also make it easier for tenants to keep pets, end the blanket bans for those on benefits or with children and will abolish Section 21, also known as 'no fault' evictions.

The full new State pension is likely to increase by almost £9 to £230 a week from next April – equating to £11,962 a year – as a result of the 'triple lock', latest wage growth figures have suggested.

- The government is urging all those across the UK who use a physical immigration document to take immediate action to transition to an eVisa. All visa holders who live in the UK and use a physical immigration document to prove their rights can visit gov.uk/eVisa to access their eVisa.
- By April 2025, all visitors who do not need a visa will need an electronic travel authorisation (ETA) to travel to the UK. An ETA costs £10 and permits multiple journeys to the UK for stays of up to six months at a time over two years or until the holder's passport expires whichever is sooner.
- A new government consultation will investigate introducing regulations for third-party services in the energy retail market. Energy brokers and price comparison websites will be among those set to be held to account by a new regulatory regime, to provide better protections and save money for consumers and businesses. The proposals are a response to an increase in individuals being scammed by unregulated brokers and other third-party intermediaries.
- The Driver and Vehicle Standards Agency (DVSA) is warning that scammers are sending text messages about fake DVSA parking penalty charges. The text messages warn that failure to pay the fine could result in a driving ban, an increased fine or even a court process. The DVSA does not issue or deal with parking fines, so if you receive a text like this, you can safely ignore it. You can report scam texts to the National Cyber Security Centre for free by forwarding it to 7726.
- The Energy Secretary has committed to a consultation by the end of the year to boost minimum energy efficiency standards in private and social rented homes by 2030, potentially lowering energy bills for millions of households. Currently, private rented homes can be rented out if they meet Energy Performance Certificate E, while social rented homes have no minimum energy efficiency standard at all.

## Westminster Round-up

Conference season has been and gone, the first of the new parliament and one that brought a range of moods and emotions for the political parties.

The Liberal Democrats were the first of the major parties to hold their event, spanning 14 – 17 September in Brighton. Fresh off a hugely successful general election campaign where they gained 64 seats, the mood at the party's conference was jubilant.

Leader Sir Ed Davey delivered a speech outlining ambitions for his party to be the "biggest champions" of the NHS. He promised to do this through a focus on boosting community services, reiterating the economic and social importance of preventative solutions to healthcare - something he suggested would save taxpayers' money in the long-term.

Sir Ed also focused on bolstering social care, criticising the Government for not mentioning carers in the King's Speech, and arguing that more should be done to recognise the contributions of carers to society. The Lib Dem leader's repeated references to social care provision suggests that the party's manifesto calls for a national care service and increased social care funding will be sustained into the future.

Speeches throughout the conference were highly critical of the Conservative Party, with deputy leader Daisy Cooper slamming the party for leaving the nation's health services in a terrible state, and consistently breaking policy promises.

Sir Ed Davey rounded the conference out with a call to "consign" the Conservatives to the history books in upcoming local elections – aiming to build on the party's election gains in Tory heartlands and place his party as "constructive" opposition to Labour.

The Labour Party Conference in Liverpool followed, the party's first whilst in government for 15 years. As with the Lib Dems, the party had every reason to be positive following their resounding victory in the general election – winning a majority of 174 seats. Despite this, there was a distinct lack of 'buzz' among the delegates. A number of reasons were cited including the grim Liverpool weather, fatigue after a relentless few months and a series of unforced errors by the new government on senior ministers' receipt of gifts including clothes and football tickets

Despite this, key Labour speakers drilled home a sense of optimism with positive change a theme woven throughout keynote speeches from Keir Starmer, Rachel Reeves and Angela Rayner. This was perhaps most apparent in the speech of the Prime Minister. Outlining his ideas for a mission of "national renewal", Starmer said that we must rediscover "who we are as a country, reigniting a sense of pride and ambition for the future".

All three Labour figureheads also claimed that difficult decisions would be necessary to fix a Britain they say has been left broken by the Conservatives. Starmer was clear that tough choices would be made to reverse the "decimated" state of UK finances, public services and communities.

Despite this, Starmer and his Labour colleagues promised that Labour would lead Britain through this period and into a more prosperous future. This included on pensions, as the Chancellor noted in her speech that the retention of the triple lock would see the state pension rise by an estimated £1,700 over the course of this parliament. Reeves, like Starmer, was also keen to stress that she will take tough decisions in order to fix the economy – with both placing cuts to winter fuel payments in this category.

Controversy around this decision was ever present at the conference, with the Unite union expressing "outrage" that their motion calling on the Government to reverse the cuts

moved from Monday to Wednesday – the last day of the conference. When the union's motion was eventually presented, it won by a very narrow margin.

Whilst this was not binding, it indicates dissent on the matter within the Labour Party – and Richard Burgon MP, who was suspended by Labour for voting against the government on keeping the two-child benefit cap, said Starmer should respect the conference's vote.

The Conservative Party conference in Birmingham was dominated by the then four leadership hopefuls jockeying for position and gladhanding hard in the hope of picking up vital support.

Each remaining leadership candidate received just 20 minutes on the conference stage to make their case. Despite the party's hammering at the July election this format caught the attention of the political class ensuring more interest than might otherwise be expected in a party of just 121 MPs. At time of writing Kemi Badenoch, James Cleverly, Tom Tugendhat, and bookies' favourite Robert Jenrick remain in the race with MPs set to whittle the field further before two candidates go out to the party membership for a final few weeks of desperate stump speeches and events. The final result of the leadership contest will be announced on the 2nd of November.

With discussions around pensions arising at all major party conferences this year, it is clear that current policy towards those in later life, particularly cuts to winter fuel payments, is a contentious topic. Later Life Ambitions will continue to campaign across party lines to propose positive solutions to current policy predicaments – and fight for a fairer future for the growing group of UK citizens in later life.

## Life After the Job

My name is Christina and this is my account of how after 32 years of policing, I took a chance and invested in making my childhood dream a reality by becoming an airline pilot.

Even though two years have now passed since I started flying passengers I am still pinching myself to believe the reality each time I take my seat on the flight deck of the Airbus A321 for Wizz Air UK.

Aviation has been my lifelong passion, however, domestic and financial circumstances prevented me from making it my initial career path.

Instead, I set my sights on making a career in policing whilst indulging my aviation passion by completing a Private Pilot Licence course and using it to fly light aircraft to various airfields around the UK and France, something I still do today.

As Police retirement loomed ever closer I started researching the possibility of forging some kind of



second career in aviation, never for one moment thinking that Airline flying was a possibility for someone coming new to the industry in later life.

Having been encouraged to apply for a British Women Pilots Association Ground School scholarship in 2016. I was totally overwhelmed to receive the award and be able to use it to forge a new career path.

I applied myself to my studies and quickly completed the first six Air Transport Pilot Licence (ATPL) exams with first-time passes. However, life then threw a curveball in the form of a close family member suffering a critical illness. This forced me to pause my studies, but I was determined not to give up on my dream. In July 2018, circumstances allowed me to restart my ATPL exams from scratch, and by March 2019 I had proudly completed all 14 exams with good scores.

I had also seen that an industry wide shortage of qualified pilots was developing, so started thinking that just maybe I might be able to secure a piloting job.

There was now no stopping me and I moved straight into a combined modular multi enaine/commercial pilot licence/instrument rating and multi-crew cooperation including upset prevention and recovery training course, which I completed in September 2019.

I now had all the qualifications required to apply for those coveted positions, and started submitting my CV applying wherever vacancies were likely to arise.

It was at this point that life once more produced further challenges in the form of two major UK airlines collapsing, flooding the market

when, in the space of a fortnight during November 2021, I obtained my Flight Instructor Rating and accepted an offer of employment as a first officer for Wizz Air UK.

Despite the curveballs, I have thoroughly enjoyed every aspect of my journey, which has tested me to the limit whilst enabling me to fly a range of aircraft from the little single engine Piper PA-28 up to the Airbus A320/A321 family. I have met some amazing people along the way, who have inspired me when times are tough and helped me remain determined to achieve my goals. I have also learned that the tried and

with experienced pilots, just prior to COVID-19 arriving to completely change the worldwide aviation landscape once more.

I continued to revalidate my hard-earned ratings whilst remaining 'job ready' by conducting flight experience sessions on a Boeing 737 fixed base simulator. Although not quite what I had initially planned, the simulator job was great fun, allowing me to share the passion of aviation whilst keeping my skills current.

This resilience started to pay back

tested T-D-O-D-A-R (Time, Diagnosis, Options, Decide, Assign, Review) decision model used in aviation ( similar to the Police NDM wheel ) can be effectively applied outside the flight deck to pick up the pieces of life's ever-changing circumstances and make an appropriate decision on the way forward.

One thing that has become abundantly clear is that many of the core competencies exhibited by Police Officers and staff are readily transferable to other careers and

in the case of aviation helped me answer those tricky "Tell me about a time when..." interview questions concerning Communication, Workload Management, Situational Awareness, Knowledge, Application of Procedures, Problem solving and Decision Making. Perhaps unsurprising then that I found myself to be one of four pilots at Wizz UK who had made the change from a previous career in policing.

My practical advice for those embarking on a similar journey is:

- Remember that everybody's pathway is different and sometimes life tries to trip you up, but work hard, remain focussed and positive, accept assistance and keep going!
- Keep the core competencies for pilots in mind and whenever you do something that demonstrates a strength in a competency then be sure to make a note of the event so that you can recount it when asked.

I hope that, by telling my story, I can demonstrate that becoming an airline pilot can be a reality for those who commit 100% to a mid-life career change and chase their aviation dreams. I have also found from my experience with Wizz Air UK that forward-thinking airlines actively embrace a diverse workforce, creating a supportive environment where everyone feels that sense of belonging, whatever their background. It has been a tough but enjoyable journey so far, and I am loving this new life and the learning that continues every day.

## **Festive** Santa **Decoration**

Make a Festive Santa decoration with our handy step by step guide.





**STEP 1:** Cut your toilet roll tube into 4 equal rounds; set the other 3 aside. Prep your red yarn by cutting individual lengths of 44cm; remember to cut enough to cover the your section of tube. For a thicker hat, use more yarn/ thicker yarn.



STEP 2: Loop a strand of red yarn in half. Insert the loop into the toilet roll tube and using your finger to hold it in place, thread the other side of the yarn through the loop. Do this multiple times working your way around the tube until no more cardboard is on show and you have

lots of dangling red threads.



**STEP 5:** Take the white yarn and wrap it round your thumb and forefinger multiple times until you have a thick roll of yarn to make a beard. Using a long piece of white yarn, tie a knot in the centre of the rolled yarn and leave the tails of the long piece of yarn attached (you will use this later to create the loop to hang the decoration). You now have the makings of a pompom!





**STEP 7:** Insert your cotton wool ball/a little stuffing inside the hat to ensure it keeps its shape. Then taking the long white yarn tail which should still be attached to the beard, thread this through the hat with a needle so it pokes out the top of the pompom on your hat. Ensure you're happy with the placement of the beard (you may need to fluff it up a little bit), then create a loop with the white yarn at the top of the hat and tie a knot to fix in place.



**STEP 3:** Gather all the dangling threads of red yarn together and using another strand of red yarn, tie a knot so it forms a santa hat. Cut the dangling pieces of yarn to create a pompom on top of your santa hat. Leave it as fluffy or short as you like. Set aside.



**STEP 6:** Using a pair of scissors, cut the loops on the rolled yarn to create your santa beard.



**STEP 8:** Finish by glueing on a gold bead/button to give your santa a nose.

Your santa decoration is now finished; you can now make 3 more with the remaining toilet roll tubes!

## What's Cooking

A smaller gathering for Christmas still deserves something special. Cote de Boeuf is a single rib of beef, it's a very juicy and flavourful cut. The béarnaise sauce is a perfect companion with all that delicious, fresh tarragon.

#### Serves 2-3

#### **Ingredients**For the filling:

750g cote de boeuf
150g butter
50ml white wine vinegar
1 small shallot, finely diced
1 small bunch tarragon, stalks and leaves separated and finely chopped
2 egg yolks

#### Method

Remove the cote de boeuf from any packaging, pat dry with kitchen towel and set aside to come to room temperature for 1-2 hours.

Add the vinegar, shallots, tarragon stalks and a few cracks of black pepper to a pan over a medium high heat and cook down for 2 minutes, then leave to cool.

Clarify the butter by melting in a pan over a low heat. Skim any solids off the

surface and discard and leave the butter to cool for a few minutes. The milk solids will settle at the bottom so pour off the yellow clarified butter leaving the white solids to be discarded. You should have roughly 100g of the clarified butter, keep this warm over a low heat.

Preheat the oven to 180°/160° fan/gas mark 4 and heat a heavy based frying pan over a high heat.

Season the beef generously with flakey sea salt.

Holding the steak with tongs sear the fat side down first to render all the fat, 2-4 minutes.

Turn the beef on its side and sear for 3-4 minutes, turn the steak and repeat on the other side

Transfer the pan to the preheated oven. I recommend using a meat thermometer to check the internal temperature to cook the steak exactly to your liking. Next is a guide for the perfect temperature:

Rare -  $45^{\circ}$  to  $50^{\circ}$ , Medium rare -  $50^{\circ}$  to  $55^{\circ}$ , Medium -  $55^{\circ}$  to  $60^{\circ}$ , Medium well -  $60^{\circ}$  to  $65^{\circ}$ , Well done-  $65^{\circ}$  to  $70^{\circ}$ .

Start by cooking it for 8 minutes for rare.

Once it has reached the lower end of your preferred range remove from the oven and leave to rest in a warm place for 20 minutes, the internal temperature will rise during this time.

Place the vinegar mixture and the egg yolks in a tall, narrow container that fits your stick blender, blitz with the blender to combine.

With the stick blender on high, slowly drizzle in the clarified butter until all its combined in a thick, glossy sauce.

You can add a tablespoon of water at a time while blitzing it to loosen the sauce if you prefer it thinner. Stir in the tarragon leaves.

Slice the steak and serve alongside the béarnaise sauce.



## What's Cooking

A decadent Christmas feast shouldn't be reserved only for the meat eaters, this vegan wellington makes a beautiful and absolutely scrumptious centrepiece that's full of classic seasonal flavours.

#### Serves 4

#### Ingredients

3 tbsp olive oil

1 large onion, diced

6 garlic cloves, minced

6-8 sprigs of thyme, leaves picked

1/3 whole nutmeg, finely grated

500g chestnut mushrooms, chopped 350g roasted and peeled chestnuts

50g walnuts 2 sheets ready rolled vegan puff pastry

1/2 tsp dijon mustard

2 tbsp oat milk

#### Method

Heat 1 tbsp oil in a large sauté pan over a medium heat. Add the onions and sweat down for 10 minutes, stirring regularly. Add the garlic, thyme, nutmeg and salt to taste and cook for a further 2 minutes. Remove from the pan and set aside to cool.

Heat 1tbsp oil in the pan over a medium high heat and add half the mushrooms to the pan in a single layer, so they brown and don't steam. Cook for 5 minutes, remove from the pan to cool. Repeat with the last 1tbsp oil and the other half of the mushrooms.

Put the cooled onions and mushrooms in a food processor and add the chestnuts and walnuts, blitz into a chunky paste.

Preheat the oven to 200°/180° fan/gas

Place the mushroom and chestnut mixture onto a large piece of cling film, shape into a log that fits the middle of the sheets of pastry. Wrap in the cling film to pack the shape tighter and place in the fridge to chill for 10 minutes

Lay one layer of puff pastry out on a parchment lined baking tray, spread the

mustard out into a thin layer in the middle of the pastry. Unwrap the mushroom and chestnut mixture and place it in the middle of the pastry. Brush the edges of the pastry with the oat milk. Place the other sheet of puff pastry over the top, press the pastry around the filling to push out any air. Use a fork to crimp and seal the edges. Trim any excess pastry with a knife and keep to the side. Brush the wellington with the oat milk then rest in the fridge for 10 minutes. You can use the excess pastry you trimmed to create decorations, like leaves for the top of wellington, place these on the wellington after you remove it from the fridge, brush again with the oat milk and cut a small steam hole in the top, in the middle.

Bake for 45 minutes, transfer to a cutting board and leave to rest for 10 minutes.

Slice to serve.

## **Embracing Winter in Your Garden**

## **Police History Society**

### **Rethinking the Stereotype** of Parish Constables as Incompetent

Views of law enforcers before the modern police, particularly local parish constables, traditionally focuses on their contemporary portrayals in popular culture such as Shakespeare's 'Dogberry' in Much Ado about Nothing, or their caricature of the role by John Earle in 1628 who describes the constable as "a viceroy in the street" who "sits in his chair of state", "willing to arrest the drunkard for not standing in the King's name". This however is lazy history, comparable to a historian of the future writing about today's officers based on Hollywood depictions such as Bad Boys or portrayals in satirical publications such as Private Eye.

In fact, a more in-depth study of history shows that the opposite may well be true, and certainly in the view of Oliver Cromwell who told parliament that he envisaged his role of Lord Protector as akin to that of "a good constable set to keep the peace of the parish".

It is also possible to see petitions against the removal of parish constables in rural county areas, long after the establishment of the 'new police'. It took a change in the



law, with The Parish Constables Act of 1872 (all counties and towns had police forces by 1856) that the government ultimately forced the hand of areas still employing such roles - demonstrating there was still widespread interest in retaining them.

#### The role of the parish constable was supposed to be an annual civic duty amongst ratepayers in a community which was unpaid.

It was therefore not necessarily a popular role, and those who could afford to, paid others in their stead. Often these 'substitutes' as they became known, maintained their role for many years at a time, being paid to do the work in the actual appointee's place. In this sense, they would have become very familiar in their parishes as 'the constable', and, as plenty of documented evidence demonstrates, became very professional in that role.

It can therefore be shown that, in rural areas at least, where village residents were known to one another, the parish constable remained a largely effective role. It was one which was regularly undertaken by people who became experienced in the role, who demonstrated competence at it, and were therefore appointed for prolonged periods.

A full insight into the role of the parish constable is upcoming in this year's Journal of the Police History Society, which will be published to members in November. 

### Improving Your **Financial Control**

My last article for the NARPO magazine was written before we knew the outcome of the 2024 general election. Whilst we now know who won, what is less clear is what impact the new Government and their decisions will have on the personal finances of the UK Police Family over the coming years.

The new Prime Minister and the Chancellor have been very clear about the state of the public finances they have inherited, and the difficult decisions that will have to be made over the coming years. The Prime Minister has also stated that the budget at the end of October will see those with "the broadest shoulders bear the heavier burden". I'm writing this article a month before the budget and we have all seen and felt the drop in consumer confidence as many of us wonder whether we will be viewed as having "broad shoulders", and what changes this 'painful' budget could make to our finances.

I know the expression is that "nothing in life is certain except death and taxes", but I would add change to those two. There have been many changes to the personal finance world over my career; does anyone remember PEPs and TESSAs? Tax relief on pensions and mortgages has changed regularly and the possibility of reintroducing the lifetime allowance has come up for review again, just a year after it was abolished. My approach, which shouldn't be a surprise given the job I do, is to find out the facts about the changes but be as prepared as I can. By having a firm grasp of my family finances, I'm ready to make the most of tax-free allowances and any other sources of additional government contributions

or opportunities that are open to me or my family.

As I say to many Police Officers I meet, even when money is tight, it is worth ensuring that you and your family maximise your ISA allowances. Industry estimates suggest the number of adults who will pay tax on their savings interest will double to 6 million this year compared to last. Our emergency pots – the money we should put aside for the boiler service or car breakdown – must be accessible so the interest will be taxable; adults' longer-term savings can be tax-free up to £20k per person, plus for some, there is an additional £25 a month using the tax-free Friendly Society savings allowance. These products tend to include life insurance, so there may be age criteria eligibility. You can learn about Metfriendly's products for adults and children on our website at metfriendly.ora.uk.

So, how to get a better grasp of your family's finances? If you read my previous NARPO article and took the quiz, you will know whether you are a "financial optimist", "scared of money", "a big spender", a "know-itall" or a "balanced viewer". To me, you must acknowledge what kind of relationship you have with money in order to gain some degree of control.

This knowledge is important, as when winter approaches, our finances can be challenging. Even

in September, the shops are starting to fill up with Christmas stock; I have seen my first Christmas tree of the year at a recent conference venue, and my daughter has started to talk about potential Christmas presents (for her rather than me, I am sorry to say!) The pressure to buy the 'best gifts' is everywhere and reinforced by adverts. It can be hard to stick to budgets when such high emotions and temptations are involved.

So, to help you build a deeper understanding of your relationship with money, this quiz is aimed at helping you improve your overall financial control and develop your financial plan. Respond yes, no or not sure to each answer:

- Are you happy with your overall standard of livina?
- · Are you happy where you live, and can you afford it?
- Do you pay your credit card bills in full, on time, every month?
- Do you have enough income/ pension to sustain your standard of living?

The areas where you answered no or don't know are, unsurprisingly, the areas that you'll need to address in financial plan. Even if you answered yes to some or even all of the questions, it's still worth thinking about what you can do to improve your financial situation.

For this edition, we'll discover ways

to boost your personal balance sheet! There are many ways to save

money and remember, it doesn't mean you have to go without.

#### **Cut your Discretionary** Spending

What luxuries can you do without? Where can you make savings? Make sure you are making the most of all the available deals - NARPO has some great member discounts on the website. Could you eat out less frequently or at a different time of day to get a better deal? Make sure you keep an eye out for apps that can help save you money - I am a big fan of Fork for discount dining in large cities; Too Good to Go is a useful app designed to reduce food waste by offering discounted food if you go to collect it - it's currently showing a roast dinner with all the trimmings for £3.49. If you travel by train on long distances and like the luxury of first class, Seatfrog is also worth checking out. Train companies auction empty first-class seats with upgrades starting from £5 on a trip from London to York. Bearing in mind this often includes the use of the first-class lounge and food and drink on board, there are some

real bargains to be had, although be careful not to get carried away bidding in the seat auction.

#### **Look for Savings on** Fixed Expenses

Such as utility bills or motor or home insurance - it's worth spending a bit of time making sure you are getting a good deal – you can easily check by using a comparison site like moneysupermarket.com or Compare The Market.

#### **Boost your Finances**

- Sell items you no longer need not only will it help you declutter but it will also boost your finances. You can use online auction sites like eBay or Vinted, or visit physical stores like Cash Converters. Please be aware they may charge a fee.
- Consider renting a room in your house - You can find out more about rent-a-room on the gov.uk website. The rent-a-room scheme lets you earn up to £7,500 tax-free/year. The good news is that the tax exemption is automatic, so you don't have to do anything. If you earn more than this from renting, you must complete a tax return. This suggestion comes with the obvious caveats but as many firms are

promoting hybrid working, we know of many workers who are staying with friends/relatives a few nights a week and are unclear of the tax situation.

#### Make Sure You Get What You are Entitled to

Some people may not be aware of the benefits they are eligible for. For example, research found that 36% of homeowners over 65 had never checked their eligibility for state benefits. Make sure you are getting all the benefits and tax breaks you are entitled to. The Age UK or Gov.uk websites have benefit checkers and calculators to help you. If you prefer to discuss in person, visit your local Citizens Advice office - details on citizensadvice.org.uk.



## Your Legal Rights with **Affinity Resolutions**

## **Know your Rights**

Data is one of the most valuable personal items we own and with the speed of technological advances, our data is now everywhere. This unfortunately makes it easier to be scammed or for criminals to use our data for nefarious purposes.

I have written previously about ways to protect ourselves from scam callers, and in this column, I want to explain how we can check what data an organisation holds, and the steps we can take to have the data amended or removed.

Under the UK GDPR, an individual has certain rights.

#### Subject Access Requests

You have the right to ask an organisation if they are using or storing your personal information, and if they are, the reason for doing so, what the information is and for a copy. This will include any emails with your details, internal memos, telephone recordings, text or WhatsApp messages.

This right is called the right of access and is also known as making a subject access request, a SAR or a DSAR.

Anyone can make a SAR, and it is best to do so in writing. The organisation cannot charge a fee and has one calendar month to respond.

#### **Right to Rectification**

If you consider that the personal information is inaccurate, UK GDPR includes a right for individuals to have inaccurate personal data rectified or completed if it is incomplete.

Again, it best to make the request in writing and usually, the organisation has one calendar month to respond.

In certain circumstances an organisation can refuse a request for rectification, which is why this right is referred to as a "qualified right". If the organisation does refuse, they have to explain their reasons for doing so.

An example could be where a clinician decides not to alter medical notes which a patient considers to be inaccurate as the clinician believes this could affect treatment of the patient in the future. In this scenario, usually the clinician would be happy to add details that the patient has a different opinion without actually rectifying the

#### Right to Erasure

The right to erasure is also a qualified right and is sometimes referred to as the right to be forgotten.

In 2014 a Spanish gentleman, Mr González took on Google as they refused to delete an article dating from 1998 which said his home was being repossessed to pay off debts. Mr González' concern was the article appeared if he was Googled and he felt was damaging to his reputation as he was now a successful businessman.

Google refused to delete it, but the European Court of Justice agreed with Mr González and ordered Google to do so. The right to be forgotten was subsequently adopted into GDPR in 2018.

As mentioned, this right is a qualified right and the organisation can refuse, but again must give their reasons for

An example could be where an organisation wants to keep details of the name and address of a member of a club who has been excluded for violent behaviour to ensure that the member does not rejoin in the future. In this scenario, the organisation would be justified in keeping the member's name and address and the reason for the exclusion but would have no reason to keep any other data which should then be erased.

If you decide to exercise your rights and are unhappy with the organisation's response or they do not respond within the statutory timeframe, then you can complain to the Information Commissioner's Office (ICO) which is the data protection regulator.

Windows 10 devices, provided they have the latest updates installed. If this does not appear, make your there are no pendina updates. By clicking Check Now this will run a program that scans the hardware of

your device to determine whether or not Windows 11 can be supported. Reasons for Windows 11 not being supported on your device can vary but the most common is the device not being powerful enough. While the difference between 10-11 is marginal, 11 does require a more powerful processor so some models will not be able to accommodate this.
