This quarter has been a busy period for events, we had the 100-year Anniversary of the Welfare Fund which was held at Police Headquarters Weston Road on 5/7/2024. It was hosted by the Chief Constable Chris Noble and was a well-attended event. It was good to see old colleagues, who during their service had contributed to the continued success of the Welfare Fund.

Delegates from Staffordshire NARPO attended the Annual Conference of NARPO which this year was held in Torquay on 6/9/2024. ### From the archive: Research by Mark Judson

In February 1959 Sergeants and Constables in the Staffordshire County Police will be going about their duties wearing their new headgear. The Staffordshire County Police has gone over to helmets in preference to peaked caps.

Comment by the public seemed to be in favour of the change. the view generally being that the helmets add dignity to the officers of the law.

The more modern type of peaked cap now issued to the Policewomen appears to be amenable to the lady's hair style, than the more masculine hat that they have been wearing previously.

The helmets are of a standard pattern with a chromium plated rose top. The badge an enlargement of the type formally used; it displays the Stafford Knot prominently against a dark green enameled background surrounded by a King Edwards Crown.

Officers on clerical or motor patrol duties will not normally wear helmets, although they are being issued to all so that they can be worn if the occasion demands.

### **Pension Remedy**

Eligible members of the police pension scheme have more choices about the benefits they receive for service between **1 April 2015 and 31 March 2022**. This is known as the Remedy Period and these choices are referred to as 'remedy' – you may have also heard them linked to the 'McCloud' review. Briefly, pension choices taken in the qualifying period allow pensioners to seek a correction if they were adversely affected by the choices given at the time of taking their police pension. All pensions taken in this time may be eligible.

Please visit the National Police Chief's Council {NPCC} national website at www.policepensioninfo.co.uk where you will be able to find a link to the useful information, FAQ's, member remedy documentation and a video to help you understand your choices. We are aware that members are struggling to find information relating to the McCloud Remedy and we wanted to help members find that information.

They have set up a dedicated website for all things Remedy, accessed at https://policepensioninfo.co.uk/latest-news/. There are a number of Member Remedy flyers and an extensive FAQ section where you should be able to find the answers to many of your questions.
